

Cocker Spaniel Rescue Worldwide Adoption Agreement

Please read through each line of this contract carefully and initial each individual clause. Be aware that CSRW will not tolerate neglect in any of the following issues and WILL remove any animal found to be in violation of any of the following clauses.

WHEREAS Adopter wishes to adopt, and wishes Cocker Spaniel Rescue Worldwide to place for adoption, the following dog:

Now, therefore, for good and valuable consideration, the parties to the Agreement agree as follows:

1. Adopter agrees to make a \$350 donation to CSRW in consideration of the rescue and transport of this animal. This donation shall be used to help CSRW offset the large expenses incurred in rescuing, vetting, boarding and caring for these dogs. You are NOT paying for an animal; you are donating to the cause of rescue.

2. All dogs placed for adoption have been examined by a certified veterinarian unless otherwise agreed upon by adopter and CSRW. CSRW does not claim that the adoptive pet will be in complete health at the time of adoption. These are rescued animals and have endured abuse. We only claim to have saved them from death, provided basic health care and basic sheltering needs. All procedures done will be clearly stated in their files. Nothing else is claimed.

3. Adopter shall not transfer the dog to any other person(s) without approval from CSRW. If adopter subsequently no longer wants the dog or cannot take care of dog or becomes deceased and no family members are approved to give said dog a good home, the dog will be returned to CSRW. The animal MUST be returned at the adopters expense directly to CSRW at 130 Stoneridge Rd. Chapin, SC 29036. Adopter agrees to include arrangements for this animal in his/her will or speak with family members regarding this clause in case of an unfortunate incident. Under no circumstances is said dog to be taken to an animal shelter or pound.

4. Adopter will not allow the dog to be used for medical or experimental purposes.

5. Adopter shall treat the dog humanely, particularly with respect to the provision of adequate food, water, and shelter.

Initial required here _____.

6. Adopter shall not keep or leave the dog outdoors for extended periods of time. Neither shall adopter keep the dog outdoors in a doghouse overnight or for extended periods during the day. Adopter shall not chain or tie the dog for an unreasonable period of time and never without adequate moving space and human supervision at all times. CSRW animals are inside pets only. They are not to be kept outdoors on a permanent basis. Any CSRW animal who is discovered left outdoors on a permanent basis will be removed with or without the adopters permission directly from the premises. The adopter hereby grants permission of removal of the animal and trespassing rights should this occur.

7. Adopter shall provide routine and emergency veterinary care as needed. Booster vaccinations shall be administered at least once per year with a routine examination.

Adopter agrees to give the dog a monthly heartworm preventative and flea preventative.

8. CSRW will not allow any physical altering of this animal unless written documentation from a licensed veterinarian is provided. CSRW does not allow tail docking in animals over 4 days of age. If you want a cocker with a docked tail please adopt one who has it's tail already docked. CSRW animals are never to be euthanized without permission from CSRW, unless an emergency injury requires euthanization. Adopter agrees never to euthanize this animal due to aggressive behavior; it must be returned to CSRW. If any CSRW animal passes away from any illness adopter agrees to notify CSRW within 24 hours of the death of the animal.

9. CSRW may make inquiries about and/or examine the dog at any time, upon reasonable notice to the adopter. Adopter also gives permission for CSRW to obtain any and all vet records from fosters veterinarian at any time deemed necessary.

Adopter will provide a copy of this contract to his/her vet.

10. If adopter resides in housing that is rented, adopter shall obtain permission from the landlord prior to the dog's placement with adopter. A copy of the lease approving pets in the rental housing will be acceptable.

11. Adopter understands that foster dogs typically will require time to adjust to their new homes and surroundings.

12. In the event that CSRW determines, in its sole discretion, that adopter is not providing adequate food, shelter, veterinary care, or is otherwise in breach of any of its obligations herein, CSRW shall be entitled to take back the dog and make appropriate arrangements for the dog's care and/or re-adoption.

13. CSRW makes no representations or warranties concerning the health, temperament, and/or previous ownership of the dog, other than expressly stated herein. Adopter understands that CSRW shall not be liable for any medical care, or treatment of the dog after the adoption has

occurred. CSRW makes no representations regarding the pets housebreaking and is not responsible for damages.

Adopter agrees to indemnify and hold harmless CSRW, Kerry Bryce or Smith Bryce, for and against any and all manner of actions and causes of actions, suits, debts, dues, accounts, bonds, covenants, agreements, judgments, claims, and demands whatsoever arising out of or relating to the adoption, foster, placement, and/or possession of the dog.

15. Adopter agrees that the adoptive pet shall maintain and wear an identification tag bearing his/her name owners name and address, phone number and/or OUR phone number at all times. Should you microchip your pet (which we recommend highly) please put CSRW in the emergency contact portion of the registration.

Adopter agrees that this contract for adoption is NOT complete until proof that the animal has been altered has been provided.

18. All pets who need to be returned to CSRW will be returned at the cost and time of the adopter. CSRW animals are not to be given to other persons nor are they to be taken to animal shelters. They must be returned to CSRW at 130 Stoneridge Rd. Chapin, SC 29036 only.

19. CSRW makes no warranties regarding the temperament of this pet in a new environment. CSRW does certify that this animal
